Registration for the <u>FY23 Contracting Officer Study Group (COSG)</u> is open. There are two remaining sessions to choose from as indicated in the schedule below:

✓ Each session consists of ten classes;

✓ Classes meet on Wednesdays via DAF365 Teams; and

 $\checkmark~$ Each class may consist of 2.5 - 3 hours of instruction, collaboration, and class discussion.

The COSG is intended to help candidates enhance their problem-solving skills and further develop their practical knowledge of contracting statutes and regulations. Class discussion focuses on judgment, business acumen, and the range of discretion a Contracting Officer has in certain situations. As a best practice, candidates enrolled in the COSG also go through a series of mock warrant boards (at the unit level) in preparation to meet the formal Unlimited Warrant Board.

<u>As a reminder, only warrant focal points can register students</u> at the <u>COSG Scheduler</u> SharePoint site. <u>Ensure appropriate coordination with leadership and your respective focal point in order to</u> <u>complete registration</u>. - ✓ Each session consists of ten weeks;
- ✓ Groups meet on Thursdays via DAF365 Teams (morning or afternoon sessions); and
- Each session consists of 1 hour of scenario-based Q&As and collaborative feedback.

The purpose of the ten-week CO Study Circle 2.0 is to support candidates in the final phase of their preparation to meet a Formal Unlimited Warrant Board.

Candidates are expected to have completed COSG, completed two mock boards and have a readiness endorsement from their leadership. The CO Study Circle 2.0 will focus on scenario-based mock board

questions giving candidates the opportunity to practice their responses as well as to receive constructive feedback from other candidates and facilitators.
