

772nd ESS awards six IDIQ contracts for BRAC/CI

The 772nd Enterprise Sourcing Squadron recently awarded six single-award indefinite-delivery/indefinite-quantity, firm-fixed-price contracts with a 10-year period of performance including all options for Base Realignment and Closure environmental construction optimization services to support the Air Force Civil Engineer Center Installations Directorate.

The BECOS Awards are follow-on contracts to current Base Realignment and Closure (BRAC) environmental remediation activities at BRAC installations. These performance-based remediation (PBR) efforts provide critical environmental support AFCEC's BRAC mission and enhance BRAC program capabilities within AFCEC/CIB. These new contracts support a variety of environmental restoration services and construction necessary to maintain regulatory selected remedies, implement optimization to enhance remedial progress, and advance sites to completion in a cost effective manner.

Cape Environmental Management, Inc. of Irvine, California, was awarded a ceiling of \$90,300,000 for work to be performed at former Castle, Mather and McClellan Air Force Bases, California, and is expected to be completed by Aug. 25, 2030. LATA-CTI Environmental Services LLC, Albuquerque, New Mexico, was awarded a ceiling of \$60,000,000 for work to be performed at Midwest consolidated continental U.S. locations of former Chanute Air Force Base, Illinois; General Mitchell Air Reserve Station (ARS), Wisconsin; Gentile ARS, Ohio; Grissom Air Reserve Base (ARB), Indiana; K.I. Sawyer AFB, Michigan; Newark, O'Hare ARS, Illinois; Richards-Gebaur ARS, Missouri; Rickenbacker Air National Guard Base, Ohio; and Wurtsmith AFB, Michigan. FPM Remediations Inc., Oneida, New York, was awarded a ceiling of \$60,000,000 for work to be performed at the following deactivated Air Force bases: Bergstrom Air Force Base, Texas; Brooks AFB, Texas; Carswell AFB, Texas; Eaker AFB, Arkansas; England AFB, Louisiana; Kelly AFB, Texas; Myrtle Beach AFB, South Carolina; Reese AFB, Texas; Buckley Annex, Colorado; and Lowry AFB, Colorado. Environmental Chemical Corp., Burlingame, California was awarded a ceiling of \$60,000,000 for work to be performed at Pease Air National Guard Base, New Hampshire; Loring Air Force Base (deactivated), Maine; Griffiss AFB (deactivated), New York; and Plattsburgh AFB (deactivated), New York, and is expected to be completed Aug. 23, 2030. FPM Remediations Inc., Oneida, New York, was awarded a ceiling of \$88,000,000 for work to be completed at Galena FOL, Alaska. GSINA-GILBANE II JV LLC, Flemington, New Jersey was awarded a ceiling of \$60,000,000 for work to be performed at Williams, March and Norton AFB.

The successful execution of these regional BECOS awards not only signifies years of planning and collaboration among AFICC, 772nd, and AFCEC/CI mission partners, but shows the ingenuity applied as they implemented a streamlined strategy for AFCEC/CI's largest and most challenging PBR program from a predominately large business awards to a 100% Small Business set-aside.
